In honor and memory of him, the Francis Keville Trust Fund was established in 1988 to raise funds to fight cancer, award scholarships, and to donate to other worthy charities. The Francis Keville Trust Fund's golf tournament has raised significant funds over the past 30 years for the Beth Israel Deaconess Hospital - Plymouth (formally the Jordan Hospital), the cancer radiation center was jointly named in Francis Keville's memory. The trust fund continues to donate on an annual basis to this hospital. These funds now support various worthy needs for cancer patients who are uninsured or underinsured. This Trust Fund also awards annual scholarships to worthy students at Wentworth Institute of Technology, Northeastern University and Marshfield High School. This Trust Fund has also made generous contributions to other worthy charities.
